TERMS AND CONDITIONS FOR THE "# LaLigaSingapore" COMPETITION

These Terms and Conditions will be available to consult on the website www.laliga.es/en throughout the duration of the Competition. Any doubts or queries about how the Competition works should be sent by email to the following address: web@laliga.es.

PURPOSE

The LIGA NACIONAL DE FUTBOL PROFESIONAL (hereafter '**LaLiga**') is the organiser and promoter of the '**LaLiga**' contest (hereafter '**the Competition**').

LaLiga is running the Competition to boost the visibility and exposure of one of its profiles on the social network Twitter and Facebook. The Competition will be open to all eligible Twitter and Facebook users who follow the account @LaLigaEN (excluded Facebook). To enter, users must send a message, using the hashtag #LaLigaSingapore: Among all the participants, a draw will be organized and there will be two winners, who will meet the Ambassadors of LaLiga Fernando Morientes and Fernando Sanz during the opening event of the LaLiga office in Singapore that will take place next Thursday, March 23, 2017. Specifically, A Prize Draw will be held to randomly select two (2) Winners.

LaLiga will manage the Competition.

The Competition will be governed by the following terms:

1. GEOGRAPHICAL SCOPE AND TIME FRAME

The Competition is open to Entrants residing in any country in the world.

The Competition will open on Saturday 18 March 2017 at 14:00 (Spanish time).

The Competition will close on Wednesday 22 March 2017 at 11:00 (Spanish time).

2. PERSONAL ELIGIBILITY

Only those persons who meet all the requirements set out in these Terms and Conditions will be deemed eligible Entrants.

The following are ineligible to participate in the Competition:

- Minors.
- People who are not resident in Singapore.
- LaLiga employees, directors and board members.
- First-degree relatives of LaLiga employees, directors and board members.

3. HOW TO ENTER THE COMPETITION

To enter the Competition, the following requirements must be met:

1. Entrants must have a profile on the social network Twitter and/or Facebook.
2. To enter the Competition, Entrants must send a message, using the hashtag #LaLigaSingapore: Among all the participants, a draw will be organized and there will be two winners Only the first tweet posted by an Entrant and complying with the above description will be valid. Any further tweets will be deemed invalid and will not be considered for the purposes of the Competition.
3. The Competition is not sponsored, endorsed or administered by Twitter and/or Facebook or associated with this social network in any way. By entering, Entrants relieve Twitter of any responsibility for the Competition and acknowledge that they are providing their personal information to LaLiga, not Twitter and/or Facebook.

Entering the Competition is free, meaning that no payment will be required to enter or to win the Prize. Only one Entry per person/registered user is permitted.

Entries that are incomplete or contain information that is incorrect, inaccurate or similar, which are received outside the Competition Period, or which do not meet these Terms and Conditions, will be deemed invalid.

4. ACCEPTANCE

By entering this Competition, Entrants accept all of the Terms and Conditions laid out in this document, which must be met, and waive any claims regarding these Terms and Conditions.

5. PRIZE DRAW AND WINNER

The Competition Period will run from Saturday 22 March 2017 to same day at 11:00 (Spanish time).

Subsequently, the Winner and Runners-Up will be chosen at random through a Prize Draw including all the valid Entries. The results of the Prize Draw will be final and not open to appeal.

The Winner will be notified via the same Twitter account that they used to tweet their Entry.

The Winner will have a maximum of twenty-four (24) hours from the time that they receive that notification to confirm that they accept the Prize by informing LaLiga in the manner stipulated. If the Prize is accepted, the Winner will be required to provide their name, surname(s) and postal address to LaLiga so that delivery of the Prize may be arranged. By accepting the Prize, the Entrant in question expressly consents to the publication of their name, photo and/or likeness on Facebook or Twitter in recognition of their status as the Winner.

When LaLiga contacts the Winner, it may request any information and/or documentation that it deems necessary to ensure that the Entry requirements set out in these Terms and Conditions, and any other applicable regulations, have been met, as well as any additional information and/or documentation considered necessary. If the Winner fails to provide the required information and/or documentation, they will be automatically disqualified and will forfeit the Prize.

If no response is received within twenty-four (24) hours, or if the Winner refuses to accept the Prize (or, where relevant, their parents or legal representatives do so on their behalf) or does not meet the requirements of these Terms and Conditions, LaLiga will revoke their status as the Winner and grant this status to the First Runner-Up. If it is not possible to contact that person within twenty-four (24) hours, or they reject the Prize or do not meet all the requirements in these Terms and Conditions, they will also be disqualified and the Second Runner-Up will become the Winner, and so forth. LaLiga does not accept any responsibility when no response is received.

6. PRIZE

The Winners will meet the Ambassadors of LaLiga Fernando Morientes and Fernando Sanz during the opening event of the LaLiga office in Singapore that will take place next Thursday, March 23, 2017.

Refusing the Prize will not result in the right to compensation of any kind.

The Winners must accept all legal obligations that are incumbent on them under current law in order to receive the Prize.

Should the Winners refuse the Prize, LaLiga reserves the right not to award it if it deems that no other Entries are deserving of the Prize.

On this note, the Competition and/or the Prize may be declared null and void.

LaLiga is not responsible for any circumstances that prevent enjoyment of the Prize, such as cases of force majeure, acts of God or any other causes that are not attributable to LaLiga or that are beyond LaLiga's control.

By accepting the Prize, the Winner authorises LaLiga to record, post, broadcast, publicise and distribute recordings or images of them while enjoying the Prize, and to reproduce, in whole or in part, those recordings or photographs, whether individually or in conjunction with other recordings, photographs or pictures, without temporal or geographical restrictions and without the Winner being entitled to any compensation or remuneration from LaLiga.

The Winner waives their rights over any images recorded or photographs taken of them while enjoying the Prize, and grants these rights to LaLiga, without limitation.

7. TAX LIABILITIES

The Prize will be subject to current tax legislation and the Winner must accept any tax liabilities that apply to them as a result of claiming the Prize.

If the Winner is resident in Spain and the value of the Prize awarded is over three hundred euros (€300), it will be subject to withholding tax. In this event, it will be the responsibility of LaLiga to make the corresponding payment on account as per the rates in place on the accrual date. As such, the payment on account will not be passed on to the Winner but rather borne by LaLiga, meaning that the amount it pays will be of a higher value than the benefit in kind received by the Winner.

Accordingly, where applicable, LaLiga also undertakes to send the Winner a certificate detailing the withholdings and payments on account involved, in accordance with the relevant regulations.

8. RESPONSIBILITIES

LaLiga reserves the right to disqualify any Entrant who disturbs, tampers with or undermines the Entry process or the normal operation of the Competition.

LaLiga reserves the right not to accept any Entry that does not meet the criteria laid out in these Terms and Conditions.

LaLiga also reserves the right to disqualify any Entrants who try to enter the Competition fraudulently, or with fraudulent or illicit intentions. This is without prejudice to any legal measures that may be taken against the culprits in such circumstances on a case-by-case basis.

LaLiga is exempt from any responsibility towards the Entrants should this Competition have to be cancelled or suspended due to force majeure or legal requirements. In such an event, the Entrants would be duly notified.

LaLiga disclaims any liability for incidents beyond its control that may occur to Entrants and the Prize Winner.

10. PROTECTION OF THE PERSONAL DATA OF THE COMPETITION WINNER

In fulfilment of Organic Law 15/1999 of 13 December on the Protection of Personal Data (LOPD) and its implementing regulations, we inform you that the personal data you provide will be treated confidentially, and will be recorded in a file owned by LaLiga. This file has been duly registered with the General Data Protection Registry of the Spanish Data Protection Agency and is subject to all of the security measures established in Royal Decree 1720/2007 of 21 December.

We inform you that your personal data will be used for the purposes of ensuring that your Entry is correctly handled and to deliver the Prize to the Winning Entrant. Once all of the necessary procedures have been carried out to complete the Competition, the data will cease to be used for the purposes of managing the Competition, but will continue to be used in accordance with the provisions stipulated in the Privacy Policy.

With regard to LaLiga, and in the event that the Entrant has granted their acceptance using the checkbox provided for the purpose, the Entrant is aware that their personal data will be used, even after the Competition is over, to send commercial communications by any means, including electronic commercial communications or

Finally, you may exercise your right of access, erasure, rectification and/or opposition regarding this data and revoke your consent to the receipt of electronic commercial communications by writing to LaLiga at the following email address (lopd@laliga.es) or with a letter marked for the attention of LaLiga's Legal Department at the postal address provided above, including the reference 'Protection of personal data' in both instances.

Your request must be accompanied by a photocopy of your Spanish national identity card (DNI) or other similar identification document and feature at least the minimum requirements set out by the law. If the request does not meet the specified requirements, you may be asked to amend it. No payment is required in return for exercising these rights.

LaLiga may contact the Entrant at any time to ask them to prove their age by providing a photocopy of their DNI or equivalent document. In the event that the Entrant does not provide the aforementioned documentation, LaLiga reserves the right to disqualify them from the Competition.

The personal data of the Winner

The personal data provided by the Competition Winner, specifically their name, surname(s), postal address and images/photographs/audiovisual recordings, will be recorded in a file for which LaLiga is responsible and the sole purpose of which is to ascertain the name, surname(s), NIF (tax identification number) and postal address of the Winner in order to send the Competition Prize to the address provided.

Refusal by the Winner to provide the personal data required will render it impossible for them to be awarded the Prize.

The Competition Winner may exercise their right to access, rectify, cancel and oppose the use of their personal data under the terms established by the Organic Law on the Protection of Personal Data and its implementing regulations by sending LaLiga a request to that effect.

Importing of social media data by LaLiga

LaLiga guarantees that it will apply security measures in fulfilment of the applicable regulations, as well as those which it diligently decides to implement of its own accord, though under no circumstances will it be liable for not implementing any security measures that are not required by law.

The personal data that you provide LaLiga with will not be passed on to other persons or companies for their own use.

Exemption from liability

LaLiga undertakes to use the personal data pertaining to Entrants in accordance with the applicable regulations and, in particular, (i) to treat the personal data pertaining to the Entrants to which it has access as a result of their participation in the Competition confidentially. However, it may disclose personal data and any other information relating to the Entrant when required to do so by the public authorities in the fulfilment of their legally attributed functions and in accordance with the applicable provisions; (ii) to adopt the necessary security measures – both technical and organisational – to prevent the alteration, loss, unauthorised use of or access to this personal data. Notwithstanding the foregoing, and given the current state of online security, LaLiga does not guarantee or accept any responsibility for damages of any kind which may arise from the alteration, loss or processing of the information pertaining to Entrants, or from the unauthorised access thereto or illegal use thereof by Third Parties.

Exclusions

other companies and organisations that advertise our services and which may use cookies, visitor counters or other technology to publish and offer relevant advertisements.

11. ALTERATIONS TO THE TERMS AND CONDITIONS

LaLiga reserves the right to partially or completely alter the Terms and Conditions of the Competition. Equally, LaLiga is entitled to resolve any unforeseen contingency as it deems fit and in line with the spirit and purpose of these Terms and Conditions.

12. LIMITATION OF LIABILITY

LaLiga has organised this Competition in good faith, and as such, does not accept any liability for potential losses or damages resulting from the participation of any persons in the Competition, or in relation to the enjoyment of the Prize by the Winner brought about by factors beyond its control. By participating in the Competition, Entrants relieve LaLiga of any liability arising from claims that stem from their participation in the Competition or enjoyment of the Prize, indemnifying LaLiga against such claims.

13. GOVERNING LAW AND JURISDICTION

These Terms and Conditions are governed by the laws of Spain.

LaLiga and Competition Entrants are subject to the jurisdiction of the Courts of Madrid and expressly renounce the legitimacy of any other jurisdiction.

LaLiga reserves the right to take legal action against anyone who engages in any kind of activity that could be deemed as constituting the manipulation or falsification of the Competition.
