

TERMS AND CONDITIONS TO ATTEND
THE PUBLIC VIEWING OF “EL CLASICO”

Attendants to the Event may read these terms and conditions on this website until the closing of the registration period.

OBJECTIVE

RELEVENT SPORTS, LLC, with Vat No. 5234234 and domiciled at 423 West 55TH Street, 11th Floor New York (hereinafter, the "**Organizer**") is in charge of organizing and promoting the Public Viewing in Pier 26 at Hudson River Park, located on the west side of lower Manhattan (New York) between North Moore and Hubert Street (USA), on 06 May 2018 since 12:30 am hours (New York time) for the broadcast of F.C. Barcelona - Real Madrid, C.F, corresponding to Week 36 of Campeonato Nacional de Liga de Primera División (LaLiga SANTANDER) (hereinafter the "**Event**") at 230 FIFTH in New York (USA). To carry out this **Event**, the Organizer has entered into an agreement with Liga Nacional de Fútbol Profesional, Vat no. G-78069762, Calle Torrelaguna, 60, 28043 Madrid Spain (hereinafter, "**LaLiga**").

All people interested in attending the event shall register at this website. Registration and attendance shall be governed by the following terms and conditions:

1. REGISTRATION AND ENTRANCE LIMITS.

(i) **REGISTRATION**

All people who want to attend the Event need to register on the Event website, this is: elclasiconyc.laliga.es. Attendance to the Event will be free, meaning no payment of any kind will be needed.

The registration to the Event does not give any person the right to enter to the venue of the Event, to attend the mentioned Event. The entrance to the venue where the Event will take place will be in order of arrival until full capacity of the venue is reached (first-come first-served basis), at the discretion of the organizers.

In order to register and provide us your personal data you must be at least 21 years of age. As such, by accepting the present Terms & Conditions you declare that you are over 21 years of age, and take full responsibility for this declaration. The Organizer may contact the user at any time to demand proof of their true age by supplying a photocopy of their official identity card or an equivalent document. If the user does not provide the aforementioned documentation, LaLiga reserves the right to block use of the service by the User.

(ii) **ACCESS TO THE EVENT**

In order to gain access to the venue of the Event you will need to bring a confirmation of your registration to the Event. To register to attend the Event you must be 21 years old. However, persons who register to the event may attend the event with children who are under 21 years of age. Therefore, all children under 21 years of age should be accompanied by a guardian at all times. Likewise, in order to gain access to the venue of the Event you would not access the Event with:

- Selfie sticks
- Skateboards, inline skates, or Heelies
- Sound amplification equipment

- Smoking or vaping
- Weapons of any kind

2. ACCEPTANCE.

Attendance to the Event requires acceptance of all the terms and regulations contained in this document, and is subject to compliance and reporting of whatever claim of the requirements.

You, as attendee at the Event, authorize the Organizer and LaLiga to take, post, record, broadcast, distribute and communicate publicly any images recorded or photographs taken of yourself while attending the Event, and to reproduce, in whole or in part, those images or photographs, whether individually or in conjunction with other images, photographs or pictures, incorporate them into brochures, advertisements, or any other promotional and informational materials of the Event, reproduce and communicate publicly the same for informational and promotional purposes via the Internet, without temporal or geographical restrictions and without the right to any compensation or remuneration from LaLiga.

The person who registers guarantees that the personal data provided are true, correct, and updated.

3. LIABILITY.

LaLiga shall be exempt of any liability in relation to the Event, which is exclusively organized and under the responsibility of the Organizer.

The Organizer reserves the right to deny access to or remove any participant who defrauds, alters or impairs the proper functioning and normal and mandatory operation of the Event.

The Organizer reserves the right to invalidate the attendance or participation of users who seek to participate through fraudulent means or for illicit or fraudulent purposes. This is without prejudice to the legal steps that may be taken depending on the circumstances of each case.

If by reason of force majeure or by law this Event is canceled or suspended, the Organizer shall be exempt of liability to the participants, an occurrence that would have to be promptly informed to participants.

The Organizer disclaims any liability with regards to issues that are beyond its control, which may occur to the participants.

The Organizer and LaLiga are not in any way responsible for the treatment that the mass media grant the Event, in particular to personal data and images of the participants. The Organizer and LaLiga disclaim any liability in relation to participants claims and / or third parties that may arise as a result of the views and / or statements expressed and / or the use of images and / or personal data that could arise in relation to the participants in the Event and / or individuals that may appear in pictures.

Minimum age: In order to facilitate us your curriculum vitae you must be at least 21 years. Therefore, through the acceptance of the present privacy policy you warrant that you are older of such age, taking responsibility entirely of such a statement. LaLiga Organization can contact you, at any time, to request accreditation of your real age through provision of copy of your national identity document or equivalent document. Should you not provide the aforementioned documentation, LaLiga reserves the right to block you.

Purposes of the processing: We inform you that your personal data will be used to ensure and manage your participation adequately. Once all procedures necessary to complete the participation in the Event have taken place, the data will no longer be used for management of the Event, but will continue to be used in accordance with the provisions of the Privacy Policy. Lawfulness of processing: The legal basis for the processing of your data is your consent. You can withdraw your consent for the treatment of your personal data at any time.

Recipients of transfers and data processors: Your personal data will not be disclosed to other persons or companies to be used for their own purposes. However, some companies subcontracted by the LaLiga organization could access personal data and information as data processors of the treatment to provide a necessary service to organization LaLiga. Rights of persons.

You can exercise the following rights below indicated. If your application does not meet the necessary requirements, LaLiga Organization may require its correction. Your rights regarding your personal which LaLiga is responsible of, are the following:

- Right of access: check which personal data about you is in possession of LaLiga Organization.
- Right of rectification: rectify your personal data when they are inaccurate.
- Right of removal: request the deletion of your personal data.
- Right to limitation: request to limit the treatment of your personal data.
- Right of portability: request that the Organization LaLiga delivered in a computer format the personal information LaLiga owns about you.
- Right to file a claim: in the event that you consider the Organization LaLiga is not processing your data in compliance with the Law, you have the right to file a complaint within the Spanish Data Protection Agency.

Source of personal data.

6. APPLICABLE LAW AND JURISDICTION

These Terms and Conditions are governed by Spanish law.

LaLiga, the Organizer and participants in the Event are subject to the jurisdiction of the Courts and Tribunals of Madrid (Spain), and expressly waive access to any other jurisdiction that might apply to them.

The Organizer and LaLiga reserve the right to take legal action against anyone who undertakes any kind of act that could be considered an infringement of the present terms and conditions.
